## 1 REV. DR PÁDRAIG CORKERY

Lecturer in Moral Theology, Pontifical University, Maynooth

Padraig Corkery is a priest of the Diocese of Cork & Ross, where he was ordained in 1981. He obtained a BSc from UCC and an STB from the Gregorian University, Rome. His graduate studies took place at Maynooth (STL) and the Catholic University of America (STD). Fr Corkery is a lecturer in Moral Theology, Pontifical University, Maynooth (1998-present). He was a member of the Irish Commission for Justice and Peace (1993–2001), Chairman (1997–2001); and is a member of the Irish Association of Teachers of Moral Theology 1998–present. He was Dean of the Faculty of Theology from 2009 to 2015.

#### 4 REV. DR LUKE MACNAMARA OSB

Monk of Glenstal Abbey, Lecturer in Sacred Scripture

Luke Macnamara is a graduate of UCD (1994) and of the South-East General Practice Training Scheme (1998). He entered Glenstal Abbey in 1998 and was solemnly professed as a monk in 2003. He taught Greek, French and Science in the Abbey school, while also heading the Special Educational Needs Department 1999–2001 and 2005–2008, serving on the national Task Force on Dyslexia 2000–2001.

From 2001–2005 he completed his first cycle Theological Studies at the Institut Catholique in Paris and from 2008–2014 his licentiate and doctoral studies in Sacred Scripture at the Pontifical Biblical Institute in Rome. His doctoral thesis, entitled, "My Chosen Instrument": The characterisation of Paul in Acts 7:58–15:41', is with the Gregorian Biblical Press and due to be published shortly in the *Analecta Biblica* series. Since January 2015 he has been lecturing in Sacred Scripture at St Patrick's College Maynooth.

## 6 BISHOP RAY FIELD

Auxiliary Bishop of Dublin
Chair, Council for Healthcare of the Irish Bishops' Conference

Bishop Field was ordained Auxiliary Bishop of Dublin in September 1997. Prior to that he was Head Chaplain to the Defence Forces.

Bishop Field lives in Blanchardstown, Dublin and has pastoral responsibility for the North West Area of the Diocese (39 parishes). He is the Diocesan Representative for Healthcare and chairs the Council for Healthcare of the Irish Bishops' Conference. Bishop Field also chairs the Council for Immigrants of the Irish Bishops' Conference.



## 7 ARCHBISHOP CHARLES BROWN

**Apostolic Nuncio to Ireland** 

Archbishop Brown graduated from the University of Notre Dame in 1981 with a major in history. He then studied theology at Oxford University and medieval studies at the Pontifical Institute of Mediaeval Studies at the University of Toronto.

In 1989, he was ordained a priest for the Archdiocese of New York. He did parish work at Saint Brendan's Parish in the Bronx, New York City, before being sent to Rome for doctoral studies in sacramental theology at the Pontifical Atheneum of Saint Anselm.

He worked at the Congregation for the Doctrine of the Faith from 1994 until 2011 when he was appointed Apostolic Nuncio to Ireland.
